I, the undersigned do hereby consent to my own participation or the named minors' participation; either before or after he/she may reach his/her age of majority, in voluntary or recreation activities, events and/or programs of the Town of Wayland. I, the undersigned, do also agree to forever release, indemnify, defend, and hold harmless the Town of Wayland, and all their employees, agents, board members, volunteers and any and all individuals and organizations assisting or participating in any voluntary or recreation activities, events and/or programs of the Town of Wayland ("Releasees") from any and all legal claims, suits, proceedings rights of actions and causes of action that may have arisen in the past, or may be asserted in the future, directly or indirectly, from personal injuries or property damage, resulting from, suffered or incurred by, or in conjunction with participation in the Town of Wayland activities, events and/or recreation programs.

I further affirm that I have read this Consent & Release Form, and that I understand the contents of this Form. I understand that my participation is voluntary and that I am free to choose not to participate in recreation activities, events, and/or programs; I am aware of the inherent risks, nature and extent of activities and uphold that the participant is of sufficient health, skill, age, and/or ability to participate. By signing this Form, I affirm that I have voluntarily decided to participate in the Town of Wayland as volunteer or participant with full knowledge that the Releasees will not be liable to anyone for personal injuries and property damage suffered in the Town of Wayland voluntary activities or recreation activities, events and/or programs.

I also understand and agree that; no refunds are given for misconduct; Recreation Department has sole discretion regarding participation. Refunds less administrative fees (\$10 per participant per program; \$20 for summer programs) are allowed if written notice of cancellation is provided within ten (10) business days. Medical refunds are given with a physician's note. Classes missed due to common illness or scheduling conflicts cannot be refunded. Programs cancelled by the Recreation Department for low enrollment, weather, or facility conflicts will be refunded. Every effort will be made to notify and reschedule any weather related facility closings. The Recreation Department may make, have, use, publish and reproduce photographs and/or video of participants for its record, public relations purposes, recognition, and/or other projects related to the wholesome promotion of its program.

No Smoking allowed at any municipal/recreation owned facilities, parks, playgrounds, athletic fields, beaches, pools, and indoor & outdoor areas of public buildings. No alcoholic beverages allowed on any municipal property, except with prior written consent of the town board, committee, or authority having custody, management and control of the public property. No person may conduct any business or commercial calling, trade, sell or otherwise deal commodities or merchandise of any description; or solicit patronage of any sort; or advertise any such business or calling for the sale of such commodities or merchandise; or hold any public meeting. No person may solicit contributions, signatures, or any other means or support for any purpose or cause on, during, or through Recreation programs and activities. Litter must be removed by the user/participants. Dogs are not allowed on recreation playing surfaces. All dogs must be leashed in public. Permits and Participation registration are non-transferable. Do not sublet your registration/reservation. Users must leave facility within 30 minutes after the end of permitted time. Permitted Users of the Town of Wayland facilities are solely responsible for the fulfillment of the regulations of the following: State Department of Public Safety, State and Local Fire Departments, State and Local Police Departments, Internal Revenue Admission Laws (when charging a fee for event), State and Local Department of Public Health, and the Wayland Recreation Department.
